H. INTRODUCTORY ORDINANCES:

1. ORDINANCE NO. 2011-005: AN ORDINANCE OF THE CARENCRO CITY COUNCIL AMENDING ORDINANCE NO. 67-21, BY DELETING SECTION 4.10 IN ITS ENTIRETY PROVIDING THAT DEALERS SHALL NOT BE ALLOWED TO TAKE COMPENSATION IN ACCOUNTING FOR AND REMITTING THE TAX LEVIED BY ORDINANCE 67-21.

2. ORDINANCE NO. 2011-006: AN ORDINANCE OF THE CARENCRO CITY COUNCIL AMENDING THE ORDINANCE ADOPTED ON MAY 24, 1993 LEVYING A 1% SALES TAX, BY DELETING SECTION 4.12 IN ITS ENTIRETY PROVIDING THAT DEALERS SHALL NOT BE ALLOWED TO TAKE COMPENSATION IN ACCOUNTING FOR AND REMITTING THE TAX LEVIED BY THE 1993 SALES TAX ORDINANCE.
