H. INTRODUCTORY ORDINANCES:

1. ORDINANCE NO. 2011-008: AN ORDINANCE OF THE CARENCRO CITY COUNCIL PROVIDING FOR THE WATER AND SEWER RATES TO BE ADJUSTED ON NOVEMBER 1ST OF EACH YEAR IN AN AMOUNT EQUAL TO THE CONSUMER PRICE INDEX, AS PUBLISHED BY THE UNITED STATES DEPARTMENT OF LABOR, BUREAU OF LABOR STATISTICS, SAID ADJUSTMENT SHALL BE EQUAL TO THE NET PERCENTAGE CHANGE IN THE CPI FOR THE PRIOR CALENDER YEAR.

1. ORDINANCE NO. 2011-005: AN ORDINANCE OF THE CARENCRO CITY COUNCIL AMENDING ORDINANCE NO. 67-21, BY DELETING SECTION 4.10 IN ITS ENTIRETY PROVIDING THAT DEALERS SHALL NOT BE ALLOWED TO TAKE COMPENSATION IN ACCOUNTING FOR AND REMITTING THE TAX LEVIED BY ORDINANCE 67-21.

ORDINANCE NO. 2011-007: AN ORDINANCE OF THE CARENCRO CITY COUNCIL AMENDING CHAPTER 50, OFFENSES AND MISCELLANEOUS PROVISIONS, ARTICLE 1, BY ADDING A NEW SECTION 50-7-DISCHARGE OF FIREARMS, PROHIBITING THE DISCHARGE OF FIREARMS WITHIN THE TERRITORIAL LIMITS OF SUBDIVISIONS OR MOBILE HOME PARKS OR WITHIN 1,500 FEET THEREOF ANY PISTOL, RIFLES, SHOTGUNS, "BB GUNS" OR AIR RIFLES, OR ANY OTHER FIREARMS OF ANY KIND OR CHARACTER WHATSOEVER.
