ORDINANCE NO. 2011-016: AN ORDINANCE OF THE CARENCRO CITY COUNCIL ADOPTING AN ADJUSTED MILLAGE RATE OF 4.60 MILLS TO BE LEVIED UPON THE DOLLAR OF THE ASSESSED VALUATION OF ALL PROPERTY SUBJECT TO AD VALOREM TAXATION WITHIN THE CITY OF CARENCRO, PARISH OF LAFAYETTE FOR THE YEAR 2011 FOR THE PURPOSE OF RAISING REVENUE.
2. ORDINANCE NO. 2011-017: AN ORDINANCE OF THE CARENCRO CITY COUNCIL INCREASING THE MILLAGE RATE, BUT NOT IN EXCESS OF THE PRIOR'S YEAR MAXIMUM RATE ON ALL TAXABLE PROPERTY SHOWN ON THE OFFICIAL ASSESSMENT ROLL FOR THE YEAR 2011, AND WHEN COLLECTED, THE REVENUES FROM SAID TAXES SHALL BE USED ONLY FOR THE SPECIFIC PURPOSES FOR WHICH SAID TAXES HAVE BEEN LEVIED.
