ORDINANCE NO. 2012-020: AN ORDINANCE OF THE CARENCRO CITY COUNCIL ADOPTING AN ADJUSTED MILLAGE RATE OF 4.60 MILLS TO BE LEVIED UPON THE DOLLAR OF THE ASSESSED VALUATION OF ALL PROPERTY SUBJECT TO AD VALOREM TAXATION WITHIN THE CITY OF CARENCRO, PARISH OF LAFAYETTE FOR THE YEAR 2012 FOR THE PURPOSE OF RAISING REVENUE.
 - 2. ORDINANCE NO. 2012-021: AN ORDINANCE OF THE CARENCRO CITY COUNCIL INCREASING THE MILLAGE RATE, BUT NOT TO EXCESS OF THE PRIOR YEAR'S MAXIMUM RATE ON ALL TAXABLE PROPERTY SHOWN ON THE OFFICIAL ASSESSMENT ROLL FOR THE YEAR 2012, AND WHEN COLLECTED, THE

ORDINANCE NO. 2012-019: AN ORDINANCE PROVIDING FOR THE ISSUANCE AND SALE OF PUBLIC IMPROVEMENT SALES TAX REFUNDING BONDS, SERIES 2012, OF THE CITY OF CARENCRO, STATE OF LOUISIANA; PRESCRIBING THE FORM, AND FIXING THE MATURITIES THEREOF AND PROVIDING FOR THE PAYMENT OF SAID BONDS AND THE APPLICATION OF THE PROCEEDS THEREOF TO THE REFUNDING OF CERTAIN BONDS OF SAID CITY; AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.
