ORDINANCE NO: 2021-003

AN ORDINANCE OF THE CARENCRO CITY COUNCIL AMENDING THE CARENCRO CODE OF ORDINANCES OVERLAY DISTRICT REQUIREMENTS REGARDING THE DISPLAY AND SALE OF RECREATIONAL VEHICLES.

BE IT ORDAINED by the City Council of the City of Carencro, that:

SECTION 1:

The Carencro City Council now finds it necessary to amend the City of Carencro Code of Ordinances Chapter 54, Planning, Article V., Overlay District Regulations, Section 54-244 Prohibited uses, in order to permit the display and sale of Recreational Vehicles in as much as other vehicle sales and service are permitted.

SECTION 2:

In consideration of Section 1 hereinabove, it is hereby ordained that Chapter 54, Planning, Article V., Overlay District Regulations, Section 54-244, Prohibited uses, of the Code shall hereby be amended by removing the abbreviation “RVs” from item number (3), such that item number (3) shall hereafter read as follows:

“(3) Display or sale lots for the sale of manufactured homes and/or movable homes.”

SECTION 3:

EFFECTIVE DATE OF ORDINANCE:

This ordinance shall become effective immediately upon return of the ordinance to the City Clerk (after execution by the Mayor), on the tenth (10th) day after receipt of the ordinance by the Mayor without signature or veto, or upon an override of a veto, whichever occurs first.

SECTION 4:

REPEALER

Any City of Carencro ordinance or parts thereof in conflict herewith are hereby repealed.
