ORDINANCE NO. 2021-006

AN ORDINANCE OF THE CARENCRO CITY COUNCIL ADOPTING A MILLAGE RATE FOR THE TAX YEAR OF 2021 ON ALL TAXABLE PROPERTY SHOWN ON THE OFFICIAL ASSESSMENT ROLL OF THE CITY OF CARENCRO.

BE IT ORDAINED by the Carencro City Council:

SECTION 1: That the following millage is hereby levied on the 2021 tax roll on all property subject to taxation by the City of Carencro.

GENERAL ALIMONY	MILLAGE
	4.66

Be it further ordained that the proper administrative officials of the City of Carencro, State of Louisiana, be and they are hereby empowered, authorized and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said City for the year 2021, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to the law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.
