



**MINUTES  
SPECIAL MEETING

Mayor Glenn L. Brasseaux called the meeting to order at 6:00 p.m. Councilmember Danielle Capritto led the Pledge of Allegiance. Following the pledge, the mayor asked for a moment of silence for our military service personnel and their families who have served and for those who continue to serve defending our freedoms.

**RESOLUTION:**

1. Resolution 2022-029: A resolution of the Carencro City Council granting the authority to Mayor Glenn L. Brasseaux to accept the low bid from M. D. Descant, LLC for the new police station.

Mayor Brasseaux asked for questions or comments from the public.

Councilmember Sinegal made a motion to approve Resolution 2022-029; seconded by Councilmember Capritto; motion approved.

Architect Lynn Guidry presented plans of the new police station showing the outside and inside of the police station. Mr. Guidry then explained the three alternates that were included in the bid package.

Alternate #1 is adding a restroom at the Carencro Community Center; Alternate #2 is adding the acoustical wallcovering and fencing and Alternate #3 is for the streetscape.

After further discussion Mayor Brasseaux asked for a motion to accept the base bid from M. D. Descant, LLC in the amount of \$9,137,000.00.

Councilmember Arceneaux made a motion to accept the base bid from M. D. Descant, LLC; seconded by Councilmember Capritto; motion approved.

Mayor Brasseaux asked for a motion to accept alternate #1 in the amount of \$193,000.00.

Councilmember Capritto made a motion to accept alternate #1. With no second motion, alternate #1 was not accepted.

Mayor Brasseaux asked for a motion to accept alternate #2 in the amount of \$100,000.00.

Councilmember Sinegal made a motion to accept alternate #2; seconded by Councilmember Arceneaux; motion approved.

Mayor Brasseaux asked for a motion to accept alternate #3 in the amount of \$612,000.00.

Councilmember Sinegal made a motion to accept alternate \$3. With no second motion, alternate #3 was not accepted.

Mayor Brasseaux asked for questions from the public regarding the above discussion with there being none.

Councilmember Capritto made a motion to adjourn; seconded by Councilmember Sinegal; motion approved.

With no further comments, the meeting adjourned at 7:09 p.m.
