ORDINANCE NO. 2023-001

**AN ORDINANCE OF THE CARENCRO CITY COUNCIL
ANNEXING PROPERTY OF WILLOWBROOK SUBDIVISION
INTO THE CORPORATE LIMITS OF THE CITY OF CARENCRO, LOUISIANA**

BE IT ORDAINED by the City Council of the City of Carencro, that:

SECTION 1:

Upon showing that under the provisions of LSA-R.S. 33:171, et seq., the requisite Petitions for Annexation, together with requisite Certificate of the Assessor and the Registrar of Voters, have been filed with the Mayor and City Council of the City of Carencro, and that the necessary public notices have been published according to the law, all of the territory situated within the described limits below are hereby incorporated into the corporate limits of the City of Carencro, Louisiana.

THAT CERTAIN TRACT OF LAND SITUATED IN SECTION 28, TOWNSHIP 8 SOUTH, RANGE 4 EAST, CITY OF CARENCRO, LAFAYETTE PARISH, LOUISIANA, CONTAINING 24.87 ACRES AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE INTERSECTION OF THE EASTERLY R/W OF CAINWOOD CT AND THE NORTHERLY R/W LINE OF IRA STREET (60' R/W); SAID POINT BEING KNOWN AS THE POINT OF COMMENCEMENT (POC); THENCE PROCEED ALONG THE NORTHERLY R/W OF IRA STREET (60' R/W) SOUTH 89°32'09" EAST A DISTANCE OF 62.34 FEET TO A FOUND ½ INCH IRON ROD, THENCE PROCEED NORTH 00° 15' 36" EAST A DISTANCE OF 200.00 FEET AND TO THE POINT OF BEGINNING (POB).

THENCE PROCEED NORTH; 00° 15'36" EAST A DISTANCE OF 1114.65 FEET;

THENCE PROCEED SOUTH 88° 54'40"EAST A DISTANCE OF 979.58 FEET;

THENCE PROCEED SOUTH 00° 22'50" WEST A DISTANCE OF 952.72 FEET;

THENCE PROCEED SOUTH 01° 39'27" WEST A DISTANCE OF 148.21 FEET;

THENCE PROCEED NORTH 89°42'58" WEST A DISTANCE OF 937.86 FEET TO THE POINT OF BEGINNING (POB).
