Sealed bids will be received by the City of Carencro, up to the hour of 2:00 o'clock p.m. CST, 210 East St. Peter Street, Carencro, LA 70520, on MONDAY, JANUARY 7, 2025, and shall at that time and place will be publicly opened and read aloud, for the PELICAN PARK PAVILION & KITCHEN AND RESTROOM PROJECT, and including all necessary labor, materials, equipment, tools, etc., required as set forth in the Project Manual and Structural Drawings of Istre Engineering Services, Inc., and the Mechanical, Electrical and Plumbing specifications and drawings of Associated Design Group, Inc.

and labeled "**Pelican Park Pavilion Kitchen & Restroom Project Bid**" with the contractor's license number on the bid envelope. Paper Bids must be accompanied by a bid bond in the amount equal to 5% of the bid, made payable to the City of Carencro, as a guarantee that

the bidder will furnish all necessary bonds and enter into a contract if the bid is accepted. Electronic bidders will upload a clear copy of their original bid bond with their bid submission and will provide their contractor's license number as part of the uploaded package. If the apparent low bidder, the original bid bond will be delivered to the City of Carencro within seventy-two hours of receipt of notification of low bidder status.

Bond sureties must appear as acceptable on the U.S. Department of Treasury Circular 570 and be licensed to do business in the State of Louisiana. No bidder may withdraw their bid within forty-five (45) days after the actual date of the opening thereof, unless withdrawal of bid is in accordance with LA. R.S. 38:2214C.

A non-mandatory pre-bid meeting will be held at Carencro City Hall on December 19, 2024, at 10:00 a.m., and potential bidders are urged to attend.
